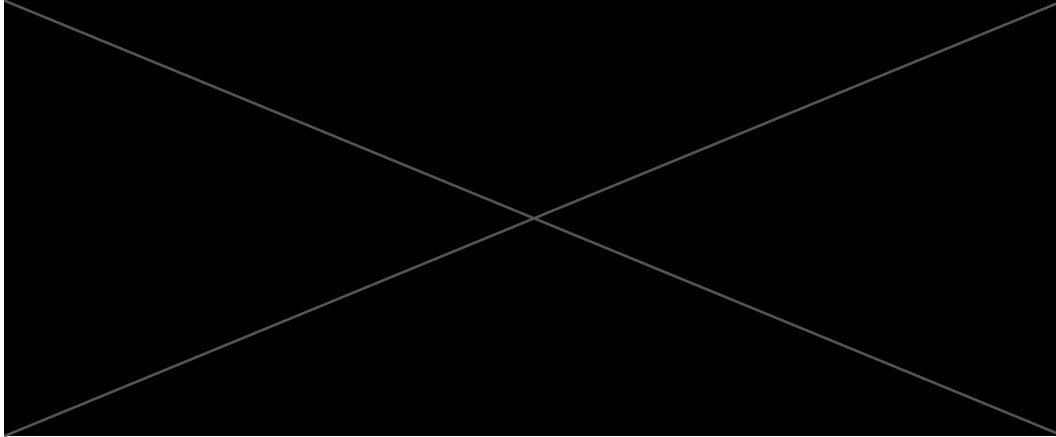

### **Applications Terms:**

- Full payment, application, medical & booking forms, completes booking & secures berth on selected voyage. There are no holds, deposits or wait listing for voyages. There are only 24 positions open per voyage.
- Applicants must be between 15-18 years.
- Application must be in hand writing only.
- If applicant under 18 years, consent needs to be signed on medical form by parent/ guardian

### **General Notes for Voyage:**

1. Access to the deck and facilities are down ladders. The ship is traditionally built, so lifts, ramps and disabled access are not available. Toilet facilities are located below the main deck area.
2. Flat soled closed shoes to be worn. Bare feet, ugg boots, thongs, high heels will not be allowed on board. Recommended to wear comfortable clothing for ease of climbing and moving around the ship.
3. All passengers agree to behave in a responsible manner when on or in the vicinity of the ship and have due consideration for other passengers and the crew of the ship. Passengers may be refused entry to the ship if they are under the influence of alcohol or drugs.
4. For safety reasons no smoking/ vaping, and no alcohol can be brought, consumed or served on the ship.
5. Excludes travel to and from to locations outside of this voyage program.
6. As owner of the vessel, The One and All, the Department of Planning, Transport and Infrastructure (DPTI) and its affiliated entities, neither own nor operate, apart from the crew paid by DPTI, any person or entity which is to, or does, provide goods or services for this trip. Because DPTI does not maintain any control over the personnel, equipment, or operations of these suppliers, DPTI assumes no responsibility for and cannot be held liable for any personal injury, death, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be occasioned by reason of (1) any wrongful, negligent, wilful, or unauthorized acts or omissions on the part of any of the tour suppliers, or other employees or agents, (2) any defect in or failure of any vehicle, equipment, instrument owned, operated or otherwise by any of these suppliers, or (3) any wrongful, wilful, or negligent act or omissions on any part of any other party not under the supervision or control of the Operator.
7. Booking Policies
  - (a) Voyage is confirmed on payment of full fee, booking and medical forms.
  - (b) Voyage may be cancelled due to predicted extreme weather conditions or the ship being unexpectedly rendered unfit for sailing. In these cases, any booking will be moved to next voyage event.
  - (c) If a booking is cancelled then the following cancellation fees may apply:

(i) 1 or more months prior to event	20% of booking
(ii) Less 1 month to 14 days prior to event	50% of booking
(iii) less than 14 days before departure	100% of booking
